Position & Responsibilities:

- _____ *Chief:* Service as Chief includes planning and leading all Chapter meetings and events; appointing non-elected Officers; training, and supervising all Officers; leading Lakota at Lodge, District, and Council events; and other tasks as necessary.
- _____ *Vice-Chief* Service as Vice Chief includes leadership in the absence of the Chief (or a Designated Representative of the Chief); recruiting, training, and supervising the OA Unite Representatives; and other duties as assigned by the Chief.
- _____ *Sachem:* Service as Sachem includes recruitment, training, and supervision of a Deputy and Communications Committee; roster; newsletter; website; and other duties as assigned by the Chief.
- _____ *Treasurer:* Service as Treasurer includes recruitment, training, and supervision of a Deputy and Finance Committee; up to date inventory and financial statements; creating and managing the budget; Trading Post oversight, and other duties as assigned by the Chief.

APPOINTED OFFICERS

Position & Responsibilities:

- _____ *Elangomat:* Service as Elangomat Chair includes organizing the OA candidates prior to and at Ordeals; regular interaction with the Hunter & Niamat Chaire; recruitment, training, and supervision of a Deputy and Elangomats both at the Ordeals and through the Extended Elangomat program; and other duties as assigned by the Chief.
- _____ *Hunter:* Service as Hunter includes organizing the OA Elections for all eligible units in Pacifica District; contacting all eligible units as needed; recruitment, training, and supervision of a Deputy and Elections Teams; and other duties as assigned by the Chief.
- _____ *Medicine Man:* Service as Medicine Man includes leadership of all Ceremonies and/or Dance Teams; recruitment, training, and supervision of a Deputy and ceremonialists; inventory and improvement of Chapter regalia; and other duties as assigned by the Chief.
- _____ *Messenger:* Service as Messenger includes promoting camping throughout Pacifica District; contacting every Pacifica unit to offer help with camping needs; surveying units to learn of camping problems Lakota could address; and other duties as assigned by the Chief.
- _____ *Niamat::* Serves as the head of Brotherhood and Brotherhood conversion with duties to include recruitment and training of Niamats, regular contact with all Lakota Arrowmen eligible for conversion, regular intereatcion with the Elangomat Chair for the Extended Elangomat program and the Path to Brotherhood, and other duties as assigned by the Chief.
- _____ *Trading Post:* Service as the Trading Post Chair includes recruiting, training, and supervising a Deputy and TP Staff; keeping up to date inventory and financial records; service on the Finance Committee under the supervision of the Treasurer; and other duties as assigned by the Chief.
